## CONSTITUTION OF QUEENSLAND 2001

NO. 80 of 2001 **(Not an Act)**

Private Corporation Seal of the "Queensland Government" and © State of Queensland 2001

**Hansard**; "The **office holders** under this Act include the **Governor of Queensland**, the **Ministers of the Crown** and the **judges** of the Supreme and District Courts. This law is of supreme importance."

**(Note; No separation of Powers; All Authority under the Premier)**

"The Constitution of Queensland 2001 does not include a statement of executive power vesting in the Sovereign as recommended by LCARC." = "Legal, Constitutional and Administrative Review Committee " **(Note; NO authority of the Crown)**

**Premier the Hon Peter Beattie MP**; My Government **(Note; a private Government for the Premier in total control of the Governor, Ministers and Judges; NOT the peoples Government)**

Those provisions that are said to be referendum entrenched remain untouched in the shells of **their** current Acts. **(Note; Two sets of Laws and this Act removed section 14 of Queensland's Constitution 1867 without a Referendum as at section 53 (shall be of no effect as an Act. ))**

### Constitution of Queensland 2001 annotated guide

Governor's commission—is sealed with the Public Seal of the State **(Note; Corporation Seal)**

A seal is a device that leaves an impression on paper and provides a mark of authenticity on certain official instruments. The "Public Seal of the State" is the seal that demonstrates the Sovereign's authority in Queensland. Examples of documents that the Governor seals with the Public Seal of the State include commissions appointing members of **the judiciary, Deputy Governors, Ministers and Executive Councillors**, as well as various types of proclamations. **(Note; All sealed with the "Public Seal of the State " to the Corporation Queensland Government; NO authority over the People of Queensland)**

### Constitution of Queensland 2001

#### PART 5—POWERS OF THE STATE

##### 51 Powers of the State

(1) The Executive Government of the State of Queensland (the "**State**") has all the powers, and the legal capacity, of an individual. **(Note; NO Crown Authority)**

All courts shall take judicial notice of the impression of the "Public Seal of the State"

**(Note; they changed "Seal of Queensland" to the Corporations Queensland Government's "Public Seal of the State" Solicitors swear their oath to these Corporation Courts under this Seal; Therefore NOT representing the people paying them. This so called Act is contra to the Commonwealth of Australia Constitution Act 1901 and Queensland's Constitution Act 1867**
