- 1. Mandate a full investigation, maybe even a Royal Commission, into the Queensland Police Service and into those people behind the scenes that draw up such draconian and murderous schemes against innocent people,
- 2. For future scenes like this one where the targeted victim is at home and is surrounded by Police Officers, the victim;
  - a) Call your lawyer and/or a close friend/minister/someone of standing and remain on the telephone, mobile phone, skype or whatsapp call during the duration of the encounter,
  - b) Record as much of the event as possible,
  - c) If a computer is available, blast out an email to your database, as I did, with a brief but explosive caption-heading to draw immediate attention by anymore at that time on the net,
    - "Urgent, Police Siege at my home, aggressive police officer preparing to crash through my front door, I may be killed, get help now)"
  - d) Tactic: Draw 100 people to the neighbouring property to assemble so you have strength in numbers so the group, each acting as a Commonwealth Public Official (CPO) by reason they themselves witnessed a breach of the peace by the Police, can approach the police officers, ask for the wo/man in charge, and command them to immediately step down and leave by reason they committed the offence of breach of the peace and that they would be reported to their senior officers if they did not immediately vacate. Ensure 100 people are making phone recordings and some uploading to Youtube and Bitchute. Even if there are only 20 civilians turned up, its sufficient numbers to approach the Police and cause them concern that the public are aware and rallying.

If the Police refuse to step down, then the CPO's are within their right to affect a citizen's arrest of the Offending Police Officers who themselves have acted contrary to their office and their code of conduct and the CPOs can arrest the Police Officers by two CPOs per Police Officer, each man holding a Police Officer's arm tightly and stating they are under arrest for offences.

This should occur spontaneously upon the Senior attending officer's confession to refusal to step down, so that all officers are immediately and effectively "taken out", so backup cannot be called upon.

- d) A delegated person should be contacting:
  - Federal Police for assistance
  - Office of the State Attorney General

- The office of the Governor General
- The media, Channel 2, 7, 9, 10 in that order (likely the 1st calls)
- Mark P, who has access to about 20 foreign groups and can make the case go universal very quickly

The key is to expose the Police Corruption as far and wide as quickly as possible so as to create awareness rapidly with the outcome that the siege is abandoned quickly.

It is we the people who need to step up and take charge, as it's we the people who have the real power through numbers

For this reason a private non registered, not for profit, non government entity, association (the National Association of active CPOs) ought be created for the purpose of;

- 1. Community protection and preservation
- 2. To draw membership so as to;
- a) Create a large Association that protects its members as well as the general community
  - b) Raise funds so it has a war chest to take on legal cases, as well as fund awareness and education processes in the mainstream media in an effort to awaken the majority of the people
  - c) Show it has integrity and competence
  - e) Has clout and authority, on behalf of its members, to speak with mainstream media when confrontations or controversies emerge
